**Sub: JIT to ensure IR calculation from quarter-wise subsidy from the beginning of term loan till end of eligible period of IR under the RR-TUFS Scheme:

Sir,


During scrutiny of RR-TUFS claims forwarded by the Regional Office of the Textile Commissioner to this office, often it has been observed that in some cases the JIT, in their JIT report has recommended period of eligible quarters which are at variance from the period mentioned in UID. Due to such unexplained discrepancy in the JIT report, many times query is raised for more clarity on the issue resulting into avoidable delays.

2. In this regard, it is to inform you that this office vide letter No.5 (1)(2)/RR-TUFS-Policy/2020/TUFS-Part file dtd.09.09.2020 had issued checklist for JIT for physical verification of machines installed under RR-TUFS in which at point No. 2.g (iv) it has been clearly indicated to ensure that calculation sheet should provide quarter wise subsidy calculated from the beginning of eligible period of IR.

3. Accordingly, to prevent such a situation in future, you are requested to direct the Technical Officer of your office leading the JIT to ensure without fail that in the event of such discrepancy, it is adequately explained either in JIT report itself under column H(9) or in the covering note .

This issues with approval of Textile Commissioner.


