However, the peak rate of advl. rate of customs duty is reduced to 20% vide Notification No. 5/2004-CE dated 8-1-2004, to 15% in 2005-06 and further to 12.5% in 2006-07. There is no change in the specific rates of duties.
- (vii) Education Cess @ 2% is levied on the aggregate duty of customs in budget 2004-05 and certain items bound under International commitments have been exempted from education cess. However, exception on certain textile items withdrawn in Budget 2006-07 and it is increased to @ 3% in Budget 2007.
- (viii) Vide notificaton no. 115/2007 Cus dtd 29.11.2007, basic customs duty reduced on PFY and PSF from 7.5% to 5%, other man made filament yarns, spun yarns and staple fibers (excluding nylon) from 10% to 5%, fibre intermediate viz DMT, PTA and MEG from 7.5% to 5%
