## PRESS NOTE

The Directorate General of Foreign Trade, Ministry of Commerce & Industry, had issued a Notification No.26 (RE-2008)/2004-09 dated 22.7.2008, whereby all export of raw cotton are subject to the Export Authorization Registration procedure with the Textile Commissioner, Mumbai. The export contract must be registered prior to the shipment. The said Notification also covers cotton waste (including yarn waste and garnetted stock) and cotton, carded or combed in addition to raw cotton (lint).

Accordingly, the Textile Commissioner has issued a Memorandum – I today prescribing the terms and conditions for Export Authorization Registration in respect of raw cotton/cotton waste/cotton, carded or combed. All exporters shall have to register their export contract in respect of raw cotton/cotton waste/cotton, carded or combed prior to shipment with the Textile Commissioner, Government of India, Mumbai.
