Sub: Online Portal i-PowerTex India – Guidelines for Operations.

Sir,

You are aware that all applications under PowerTex India have to be made mandatorily by online in www.i-powertexindia.gov.in w.e.f 01.01.2018. All the operations/activities in respect of online applications have also to be made compulsorily through online by the concerned Powerloom Service Centres, Regional Offices and PDC, Headquarters. One round of training has already been completed in all the major Powerloom Clusters by M/s. Silvertouch Technologies Pvt. Ltd. The Powerloom Service Centres and Regional Offices are expected to facilitate the online applications by Powerloom weavers and streamline the entire process

In case of all In-Situ applications received manually prior to 01/01/2018, the same should be integrated with the iPowerTex India portal as under:-

1. In case of all In-Situ applications received in Regional Offices prior to 01/01/2018 but in principle approval have not been issued by the Regional Offices before 01/01/2018, the applicants shall be facilitated to re-submit the same by the Powerloom weavers through online only.
2. Wherever in principle approvals have been issued by the Regional Offices prior to 01/01/2018 but JIT request has not been received from the Powerloom weavers/units, the Powerloomweavers/units/benchmarked Powerloom kit/attachment/manufacturer/suppliers as the case may be should be advised to submit its request for JIT on or before 15/01/2018, through online and Regional Office should complete JIT visits and reports be

sent to PDC, Headquarters in Format- IV and proforma-I through **online** on or before 31/01/2018. If the request for JIT is not received by 15/01/2018, those in principle approvals will be deemed as cancelled and such applicants need to **apply afresh** online.

3. Wherever the request for JIT have been received by the **Regional Offices** prior to 01/01/2018, all such cases have to be visited by the JIT for **verification and verification** reports in Format- IV and along with proforma-I have to be submitted **online** by the ROs to PDC, Headquarters on or before 15/01/2018. If any such applications could not be verified by the JIT for want of documents etc. the same shall be rejected and returned manually to Powerloom Weaver/Units by the Regional Offices.
4. Adequate care should be taken by R.Os while entering the data on eligible cost/subsidy of kits/attachments as the same has been revised vide this office Memorandum No.23(2)/16-17/In-Situ/RMP/PDC/195 dated 26/12/2017.


In case of all other schemes viz. Group Workshed Scheme, Yarn Bank scheme, CFC etc, applications that are returned by Head Office, the Regional Offices should forward applications afresh through online only. In case of all applications for which in principle sanctions have been issued by this office or the old cases in which progress are at various stages, the data on the same as per prescribed format enclosed **Annexure-I, II & III** for GWSS, Yarn Bank, CFC respectively, should be forwarded to this office for integrating into the online portal. All LLMC/visit reports of the GWS/Yarn Bank/CFC should be forwarded to PDC, H.Qtrs only through online w.e.f 01.01.2018.
