1. Based on the information submitted by **M/s. Ahmedabad Packaging Industries Ltd.** in the prescribed format, the unit situated at “**Plot No.326 Phase-II, GIDC, Vatva, Ahmedabad-382445**” had been registered as a technical textile unit in the records of the Office of the Textile Commissioner and had been allotted Registration Number 05101007 as per Circular No.2 (2007-08 series) dated 07.12.2007 issued under Technology Upgradation Fund Scheme (TUFS) (01-11-2007 to 31-03-2012) of Ministry of Textiles (MoT). Now, the unit vide letter dated 13.08.2015 has requested for registration under RR-TUFS for their expansion with inclusion of locations at **Unit-II: Plot No.3904, Ph-IV, GIDC Vatva, Ahmedabad & Unit-III: Plot No.8 Pharma Zone, Ph-I, GIDC Vatva, Ahmedabad.** Accordingly, registration of **M/s. Ahmedabad Packaging Industries Ltd.** has been revalidated as a Technical Textile Unit in the records of the Office of the Textile Commissioner with same Registration Number i.e. **05101007** under RR-TUFS along with inclusion of two locations as given below:

New Proposed Unit-II : Plot No.3904, Ph-IV, GIDC Vatva, Ahmedabad-382445

The registration will remain valid till the continuation of Technology Upgradation Fund Scheme (TUFS).
