Sub: Requirements of documents for restoration of the machinery manufacturers enlisted in the Indicative List of Machinery Manufacturer under ATUFS approved by the Expert Committee (Annexure – II) under ATUFS.

The 13th Technical Advisory-Cum-Monitoring Committee (TAMC) of Amended Technology Upgradation Fund Scheme (A-TUFS) held on 23.02.2019 and it was decided by the committee that the following documents/information are required for restoring the names of the Machinery Manufacturers enlisted in Annexure-II (Indicative List of Machinery Manufacturer under ATUFS approved by the Expert Committee). The enlisted units/Authorized agents in Annexure-II are required to submit the following documents to TUFS Cell, Office of the Textile Commissioner, Mumbai-20. within six months from the date of this circular.

1. For Indigenous machinery manufacturers:

2.	Valid/Renewed ISO 9000 (ISO 14000 for processing machines & ISO 18000 for energy saving machines) or equivalent Quality Certification as per list in Appendix 2I of the Foreign Trade Policy 2015-2020 or in QMS list of QCI or in their foreign offices of these agencies who are available in these lists (The list is available in our website at http://www.txcindia.gov.in/tufs_home/tufs_home.htm) and as per Circular no.1(2018-19 series) dated 10.04.2018
3.	An undertaking from the machine manufacturer that in future if it is found that they have supplied machine other than the specified benchmarked machinery, the list of which has been put up in the website under ATUFS and on which ATUFS benefits can be claimed, then their enlistment under ATUFS will be cancelled (Undertaking form as per prescribed format in the letter head of the unit & Ink signed by authorized person with name & designation. Format is provided in our website at link http://www.txcindia.gov.in/tufs_home/tufs_home.htm)



Sr.No.	Particulars / Documents
1.	A certificate from respective Embassy / Consulate General/ Trade Council of the respective country either situated in their country or in India stating that they are Textile Machinery Manufacturer in the respective country in English.
2.	Valid/Renewed ISO 9000 (ISO 14000 for processing machines & ISO 18000 for energy saving machines) or equivalent Quality Certification as per list in Appendix 2I of the Foreign Trade Policy 2015-2020 or in QMS list of QCI or in their foreign offices of these agencies who are available in these lists (The list is available in our website at http://www.txcindia.gov.in/tufs_home/tufs_home.htm) or CE mark self certification in case of European/USA/Japanese textile machinery manufacturers and as per Circular no.1(2018-19 series) dated 10.04.2018
3.	An undertaking from the machine manufacturer that in future if it is found that they have supplied machine other than the specified benchmarked machinery, the list of which has been put up in the website under ATUFS and on which ATUFS benefits can be claimed, then their enlistment under ATUFS will be cancelled (Undertaking form as per prescribed format in the letter head of the unit & Ink signed by authorized person with name & designation. 
