Minutes of the 11th meeting of the Internal Technical Committee under Amended Technology Up gradation Fund Scheme (ATUFS) held on 29-09-2020

The 11th meeting of the Internal Technical Committee under Amended Technology Up gradation Fund Scheme (ATUFS) convened on 29-09-2020 at 03.00 PM under the Chairmanship of Shri S.P.Verma, Joint Textile Commissioner in the conference hall of the Office of the Textile Commissioner, Mumbai. The list of participants is placed below at Annexure-I. The agenda points which were discussed and decisions taken thereof are as under:-

Agenda No. 1: Confirmation of the minutes of 10th Internal Technical Committee Meeting.

Decision Taken: The Committee confirmed the minutes of the 10th Internal Technical Committee Meeting unanimously

Agenda No. 2: Verification and recommendation of 14 proposals for enlistment of Machinery Manufacturers/ Authorized Agents under ATUFS as per Para no. of 3.4 of Revised Resolution of ATUFS dated 02.08.2018 and subsequent order No. 6/5/2015-TUFS dated 06.08.2019.

Decision Taken : The list of 14 proposals (Abroad - 4, Indigenous - 7 & Authorized agents - 3) received from Textile Machine Manufacturers/Authorized Agents for enlistment under ATUFS, were scrutinized by the Internal Technical Committee and 7 proposals (Abroad- 3 & Indigenous- 3 and Authorized Agent - 1) were recommended to the Textile Commissioner for her approval and uploading the same on this office website (Attached herewith as Annexure-II). It was decided to call for the audited balance sheet for the year 2019-20 of one unit as proof of subsidiary unit and carry out Physical Verification in the case of three indigenous units. One case was deferred to the next meeting for want of explanation from unit and in two cases the Parent Manufacture has been asked to enlist only one authorized agent under ATUFS.

Agenda No. 3: Request received from M/s. Perfect Engineering Corporation regarding inclusion of Perfect Waste Recycling Machinery under ATUFS.

M/s. Perfect Engineering Corporation who is manufacturing the following textile waste recycling machinery, alongwith spinning preparatory machinery has requested for the inclusion of the following textile waste recycling machinery under ATUFS.

1. Hard Waste recycling line with special card, 1275 BSD for opening / regenerating of woven garment fabric waste, hosiery waste fabric, non-woven side cut fabric waste-spun type, weaving spun yarn catch cord & warp spun yarn waste, post consumed spun yarn woven fabric waste, spun yarn waste.
2. Cotton waste Recycling /Recovery Line for waste generated from Ginning & Spinning plants.

On both the lines, the output material is primarily re-used in non-woven, making of bleached cotton, home textiles, automotive textiles and spun yarn manufacturing. The textile waste recycling machine addresses the increase in textile waste and will save precious resources in the form of raw material and make businesses more profitable.

Decision Taken: Fibre and Yarn stage are not covered under ATUFS. Hence, proposal cannot be considered.

Agenda No. 4: Request received from M/s. Arya Enterprise for inclusion of Cone to Cone Sizing Machine under ATUFS.

M/s. Arya Enterprise, Gujarat have requested this office to include their 'Cone to Cone Sizing Machine' with creel, chemical device stand, heating chamber, oil stand, winder and PLC control panel. The said machine applies a chemical to yarn than the yarn goes to dry in the heating chamber to dry and finally filled in yarn cone.

Decision Taken: Single yarn sizing machine is already permitted in which cone to cone package are being used. Hence no need to consider separately cone to cone sizing machine.
