

**Minutes of the 1<sup>st</sup> meeting of the Internal Technical Committee under Amended Technology Up gradation Fund Scheme (ATUFS) scheduled on 27.08.2019**

The 1<sup>st</sup> meeting of the Technical Committee under Amended Technology Up gradation Fund Scheme (ATUFS) convened and held on 27.08.2019 at 11.30AM under the Chairmanship of Shri S.P.Verma, Joint Textile Commissioner in the conference hall of the Office of the Textile Commissioner, Mumbai. The list of participants is at Annexure-I. The agenda points which were discussed and decisions taken thereof are as under:-

**Agenda No.1 & 2: Verification and recommendation of 66 proposals already verified and recommended by 3<sup>rd</sup> Technical Committee held on 08.02.2019 as per Para no. of 3.4 of Revised Resolution of ATUFS dated 02.08.2018 and verification & recommendation of 84 proposals for enlistment of Machinery Manufacturers under ATUFS as per Para no. of 3.4 of Revised Resolution of ATUFS dated 02.08.2018 and subsequent order no.6/5/2015-TUFS dated 06.08.2019**

Total 150 proposals verified in terms of circular no.6 (2018-2019 series) dated 31.08.2018. by the 1<sup>st</sup> Internal Technical Committee. The detailed remark made by the committee members has been mentioned in the individual proposals in the list. The list is attached and marked as Annexure-I.

The committee recommended for enlistment of 64 proposals, rejected 34 proposals and directed for physical verification of manufacturing activities of proposals in respect of 12 units. 31 proposals were referred to TAMC for policy decision. Clarification are to be called for from 5 units and the ISO of 4 units is to be verified.

In respect to the embassy certificate/Consulate General Certificate submitted by the Textile Machine Manufacturers in China, Taiwan & Turkey it was observed by the committee that the concerned Embassy /Consulate General have not certified but mentioned as "Seen in Embassy/ Embassy shall not held responsible for the documents" which is not as per Circular no.6 (2018-2019 series) dated 31.08.2018. Hence committee referred the matter to the forth coming TAMC for taking policy decision.

**Agenda No.4: Revalidation of enlisted manufacturers under Annexure-II under ATUFS approved by the Expert Committee.**

The 13<sup>th</sup> Technical Advisory-Cum-Monitoring Committee (TAMC) of Amended Technology Upgradation Fund Scheme (A-TUFS) held on 23.02.2019 and it was decided by the committee that the documents/information are required for restoring the names of the Machinery Manufacturers enlisted in Annexure-II (Indicative List of Machinery Manufacturer under ATUFS approved by the Expert Committee). The enlisted units/Authorized agents in Annexure-II are required to submit the documents to TUFS Cell, Office of the Textile Commissioner, Mumbai-20, within six months from the date of this circular. For the above circular has been issued on 27.03.2019. The expiry date for Indicative List of Machinery Manufacturer under ATUFS approved by the Expert Committee is 26.09.2019.

The committee referred the matter to the forth coming TAMC for taking policy decision.

1. MC - 4 (38) Computerized High speed fully fashioned flat bed knitted garment manufacturing machine with speed of 10 rpm and above.

In the claim of M/s. SRV Knit Tech P Ltd., Bangalore, it has been clarified that the speed of the installed two machines are 1.2 Mtrs/ Sec and 1.4 Mtrs / sec.

The committee observed that the production speed / specification of the above machine are to be measured in 1.2mts. / sec and recommended to TAMC for decision.

M - 1 C (8) High performance Tricot Machinery with minimum 3 Bar and speed of 2300 rpm and above. & MC 1 C (9) Fully Fashioned Knitting Machines.

In the claim of M/s. Omnee Creation, Surat Unit has claimed High performance Tricot Machinery in UID application. Whereas in the Commercial Invoice issued by Karl Mayer, Description of the machine mentioned as -

*"Fully Fashioned knitting machine with the following configuration: High Performance Tricot machine for production of all 3 bar articles"*

In this regard, TXC has mentioned a remark in the concerned file "Our office need to frame an opinion' on the above said machine.

The committee recommended the matter to TAMC for decision.
