

SEC 4. (1) (b) (xii) THE MANNER OF EXECUTION OF SUBSIDY PROGRAMMES, INCLUDING THE AMOUNTS ALLOCATED AND THE DETAILS OF BENEFICIARIES OF SUCH PROGRAMMES

Progress of 15% Margin Money Subsidy

Govt. of India had also introduced 15% (MMS)-TUFs applicable to Textile MSME sector on 01.04.2007. Under the scheme, an amount of Rs.254.136 crore has been disbursed as subsidy to 3003 claims upto 31.03.2026.

Progress of 30% Margin Money Subsidy

Govt. of India had also introduced 30% MMS RR-TUFs on 04.10.2013 applicable to Textile MSME sector. Under the scheme, an amount of Rs.344.2858 crore has been disbursed as subsidy to 1002 claims upto 31.03.2026. (There is no any claim under 30% in FY 2025-26.)

Progress of 15% & 30% Margin Money Subsidy

Govt. of India introduced 15% & 30% MMS RRTUFs on 4.10.2013 applicable to textile MSME sector. Under the scheme, an amount of Rs 347.32 crore has been disbursed as subsidy to 631 claims up to 31.03.2026.

Progress of Project received under GWSS

Total 344 projects have been approved up to 31.03.2026, with provision of Government subsidy of Rs.259.61 Crore for construction of workshed. Total subsidy of Rs.160.30 Crore (including one project of CFC for Rs.2 Crore) has been released up to 31.03.2026. Out of 344 projects, 142 (including 01 project of CFC) projects have been completed so far.

Progress of Project received under Pradhan Mantri credit Scheme for Powerloom Weavers.

Total 189 nos. of projects have been approved up to 31.03.2026 and total subsidy of Rs.30.45 crore has been released up to 31.03.2026 under the stand up India scheme under PMCSPP. Further, committed liabilities under Stand-up India Scheme of Pradhan Mantri Credit Scheme to be paid under Textile Cluster Development Scheme (TCDS).
