An original certificate from respective Embassy / Consulate General in regard to functioning of the unit as manufacturer of the respective machines alternatively, textile machinery manufacturers abroad should provide attested copy of the letter/Certificate regarding manufacturing of Textile machines from Indian Embassy/Consulate General in English.
2. Complete Technical Literature of all the machines manufactured by you related to undertaking - with specification of the machines.
3. Valid/Renewed ISO 9000 (ISO 14000 for processing machines & ISO 18000 for energy saving machines) or equivalent Quality Certification as per list in Appendix 21 of the Foreign Trade Policy 2015-2020 or in QMS list of QCI or in their foreign offices of these agencies who are available in these lists. (The list is available in our website at http://www.txcindia.gov.in/tufts_home/tufts_home.htm).
4. Sales Figures – Last 3 years information to be provided machine-wise – value / volume in domestic and international markets.
5. An undertaking in the letter head of the unit as per format (The format is available in our website at http://www.txcindia.gov.in/tufts_home/tufts_home.htm). Detailed specification under ATUFS has to be incorporated in the undertaking.
6. Establishment details of the machinery manufacturing units.
7. For Authorised Agents, MoU signed between Machinery Manufacturers and Authorised Agent has to be submitted. In the MoU, the percentage of commission has to be mentioned.
